ORDER

Office Order No. 83/70/2019 Dated, Bishnupur, the 13/11/2019

WHEREAS, the Principle Chief Conservator of Forest (HoFF), West Bengal vide his letter No. 9899/P &S (P)/3D-242 dated- 21.12.2017 submitted the detailed estimates for construction of Barrack for trainee at Bishnupur under Panchet Division to the Department of Forests, Govt. of West Bengal for according necessary Administrative Approval and Financial Sanction and also instructed the Divisional Forest Officer, Panchet Division to initiate the tendering process.

WHEREAS, in obedience to the instruction of the Principle Chief Conservator of Forest (HoFF), West Bengal, e- Tender was floated vide NIT No. WBFOR/PNT/RIDF/BRK- 29 (e) of 2018-19 dated 18.06.2018 by the Divisional Forest Officer, Panchet Division.

WHEREAS, due to receipt of insufficient bids against NIT No. WBFOR/PNT/RIDF/BRK- 29 (e) of 2018-19 dated 18.06.2018, re- Tender was floated vide NIT No. WBFOR/PNT/RIDF/BRK- 29 (e) of 2018-19 (2nd call) dated 24.07.2018 by the Divisional Forest Officer, Panchet Division.


WHEREAS, on completion of Tendering process with sufficient No. of eligible bids, the result sheet was submitted to the Competent Authority through proper channel for necessary approval by the Divisional Forest Officer, Panchet Division, vide Memo No. 2179/02-05 dated 30.08.2018.

WHEREAS, since then repeated correspondences have been made to the Competent Authority for according necessary approval of the e- Tender result sheet and providing Administrative Approval & Financial Sanction for the work but till date neither the result sheet has been approved nor any Administrative Approval & Financial Sanction has been accorded for the said work.

WHEREAS, the bid validity of the NIT No. WBFOR/PNT/RIDF/BRK- 29 (e) of 2018-19 (2nd call) dated 24.07.2018 has been expired as per conditions nos. 16 of I.T.B. (Instruction to Bidders) of the above stated NIT & the L₁ bidder also has requested to release his Earnest Money Deposit.

Now, considering the above, it is hereby ordered that the NIT No. WBFOR/PNT/RIDF/BRK- 29 (e) of 2018-19 (2nd call) dated 24.07.2018 is cancelled and the EMDs of L₁ & L₂ bidders which are blocked above the expiry period of bid validity are also hereby released.

All concerned are being informed accordingly.




